

3. OVE Token Utility

\$OVE is a maintenance subject for Oryve project & Oryverse.

\$OVE will be used to proceed transactions inside Oryverse.

# 3.1 OVE Trading

\$OVE will initially be tradable through a decentralized exchange "PancakeSwap" with a liquidity pair with a native Binance Smart Chain Token "BNB".

PancakeSwap being decentralized does not require your data, it just proceeds blockchain transaction.

Every Transaction of \$OVE is subject to 3% Fee, this includes:

2% Marketing/Development Fee (Refereed to as Marketing Fee)

1% Liquidity Pool Fee

Marketing/Development Fee Funds will be used to progress the growth of OVE Token and maintain Cloud Servers for Oryverse, that is why we call it "self-sustainable system".


Liquidity Pool Fee will cover the issue of slippage, the bigger the trading volume, the bigger the liquidity pool will become over time, helping significantly to prevent slippage losses.

### 3.2.1 The Optimal Variant


